

PRIVACY STATEMENT

MJ Consulting & Support (MJ) is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the MJ Consulting & Support Web site and governs data collection and usage. By using the MJ Consulting & Support website, you consent to the data practices described in this statement.

Collection of your Personal Information

MJ Consulting & Support collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number. There is also information about your computer hardware and software that is automatically collected by TPM. Use of your Personal Information

This data is used to deliver customized content and advertising within MJ Consulting & Support to customers whose behavior indicates that they are interested in a particular subject area.

Use of Cookies
